Notice of Race & Abbreviated Sailing Instructions

The race shall be held at the Port of Redwood City. The race is limited to El Toro class boats. The start and finish of the race shall be at the inner turning basin of the Port, near the launch ramp across the channel from the Sequoia Yacht Club. The actual start line shall be perpendicular to the wind near channel mark "21", the first mark is upwind to channel mark "20". The race course will be in a clockwise direction: west on Redwood Creek, west on Smith Slough, north on Steinberger Slough, east south north east south north east south east north east north east on Corkscrew slough, and south on Redwood Creek to a down wind finish adjacent to the Port of Redwood City launch ramp

The Skippers meeting shall be at 1300 at the Port of Redwood City's public launch ramp on Chesapeake Drive (off Seaport Blvd.). An entry form with signed release shall be required in order to participate. The race shall is schedule to start at 1330. The results shall be announced and trophies awarded one hour after the last boat finishes at the Sequoia Yacht Club, 441 Seaport Court, Redwood City, CA. Complimentary hors d'oeuvres provided.
